ASSUMPTION OF RISK AND RELEASE OF LIABILITY

The individual named below (referred to as "**I**" or "**me**") desires to enter the premises of the Gaetano's Banquet Center, located at 1617 Banksville Road, Pittsburgh, PA 1216 (**Premises**) to attend and/or participate in activities (**Activities**) related to a training session entitled "Let's Talk Electrical Code" on May 20, 2021. As lawful consideration for being permitted by the IAEI Western Pa Chapter to be on the Premises and engage in the Activities, I agree to all the terms and conditions set forth in this agreement (**Agreement**).

1. I am aware of the highly contagious nature of bacterial and viral diseases, including the 2019 novel coronavirus disease (COVID-19) (**Disease**), and the risk that I may be exposed to or contract the Disease or other infectious diseases by being on the Premises and engaging in the Activities. I understand and acknowledge that such exposure or infection may result in serious illness, personal injury, permanent disability, death, or property damage. I acknowledge that this risk may result from or be compounded by the actions, omissions, or negligence of others, including Gaetano's employees, IAEI Western Pa Chapter members or guests. I understand that while preventative measures have been/will be implemented to reduce the spread of the Disease, there is no guarantee that I will not become infected with the Disease or other infectious diseases while on the Premises and that being on the Premises may increase my risk of contracting the Disease.

NOTWITHSTANDING THE RISKS ASSOCIATED WITH THE DISEASE, I ACKNOWLEDGE THAT I AM VOLUNTARILY ENTERING THE PREMISES TO ENGAGE IN THE ACTIVITIES WITH KNOWLEDGE OF THE DANGER INVOLVED. I HEREBY AGREE TO ACCEPT AND ASSUME ALL RISKS OF PERSONAL INJURY, ILLNESS, DISABILITY, DEATH, OR PROPERTY DAMAGE RELATED TO THE DISEASE, ARISING FROM MY BEING ON THE PREMISES OR ENGAGING IN THE ACTIVITIES, WHETHER CAUSED BY THE NEGLIGENCE OF GAETANO'S AND THE IAEI WESTERN PA CHAPTER OR OTHERWISE.

2. I hereby expressly waive and release any and all claims, now known or hereafter known, against Gaetano's and the IAEI Western Pa Chapter, and their officers, directors, employees, agents, affiliates, successors, and assigns (collectively, "**Releasees**"), on account of injury, illness, disability, death, or property damage arising out of or attributable to my being on the Premises or engaging in the Activities and being exposed to or contracting the Disease, whether arising out of the negligence of any Releasees or otherwise. I covenant not to make or bring any such claim against any Releasee, and forever release and discharge any and all Releasees from liability under such claims.

3. I will also follow all instructions of Gaetano's and the IAEI Western Pa Chapter while on the Premises. I agree not to enter the Premises if I am experiencing symptoms of the Disease (such as cough, shortness of breath, or fever), have a confirmed or suspected case of the Disease, or have come in contact in the last 14 days with a person who has been confirmed or suspected of having the Disease.

4. This Agreement constitutes the sole and entire agreement of Gaetano's and the IAEI Western Pa Chapter and me with respect to the subject matter contained herein and supersedes all prior and

contemporaneous understandings, agreements, representations, and warranties, both written and oral, with respect to such subject matter. If any term or provision of this Agreement is invalid, illegal, or unenforceable in any jurisdiction, such invalidity, illegality, or unenforceability shall not affect any other term or provision of this Agreement or invalidate or render unenforceable such term or provision in any other jurisdiction. This Agreement is binding on and shall inure to the benefit of Gaetano's and the IAEI Western Pa Chapter and me and our respective successors and assigns. All matters arising out of or relating to this Agreement shall be governed by and construed in accordance with the internal laws of the Commonwealth of Pennsylvania without giving effect to any choice or conflict of law provisions.

BY SIGNING BELOW, I AM ENTERING INTO THIS AGREEMENT ON BEHALF OF MYSELF AND ALL OTHER INDIVIDUALS, INCLUDING ADULT AND MINOR GUESTS THAT WOULD BE ALLOWED ACCESS TO THE PREMISES ON MY IAEI MEMBERSHIP. I REPRESENT THAT I HAVE THE AUTHORITY TO BIND ALL INDIVIDUALS ON MY MEMBERSHIP TO THIS AGREEMENT.

I ACKNOWLEDGE THAT I HAVE READ AND UNDERSTAND ALL OF THE TERMS OF THIS AGREEMENT AND THAT I AM VOLUNTARILY GIVING UP SUBSTANTIAL LEGAL RIGHTS ON BEHALF OF MYSELF AND OTHER INDIVIDUALS ON MY MEMBERSHIP, INCLUDING THE RIGHT TO SUE GAETANO'S AND/OR THE IAEI WESTERN PA CHAPTER.
